Quiz Competition 2024

Scheme Document

- **1.** The office of the Comptroller and Auditor General (CAG) of India is organising the first Quiz Competition as part of *Audit Diwas* celebrations.
 - a. The competition will be open to the students with *not* more than 25 years of age (As on 01.08.2024) who are enrolled for graduation and above in a course of study in any government educational institution located in Delhi.
 - b. The competition will be held in two rounds:
 - i. First round: All participating teams will appear for the first round which will be a written quiz. From this round, six teams will be selected for the final round. The first round would be of 30-40 minutes and in written format (e.g. MCQs). The Questions in this round will be answered by both the participants sponsored by each institution separately. Combined scores of both participants of an institution will determine the qualifying score of the institution. The qualifying institution would be represented by the same team of two participants in the final round.
 - ii. **Final round**: The qualified six teams will appear for the final round, which will Stage round and determine the winner of the quiz competition.

The duration of the final quiz will be 1 hour with an allowance for 15 minutes

- iii. **Medium of the quiz:** The questions for the quiz will be presented in English.
- c. There will no registration charges/fee for participation in the competition.

 Participants will have to make their own arrangements for travelling to and fro the

 Office of CAG on the days of the quiz for both first and final rounds.

- The first rounds: In the Auditorium of Office of the CAG of India during 6-8 November 2024.
- The final round: In the Office of the CAG of India on 16 November 2024 (Afternoon).
- 7. The Winners and runners up of the competition will be awarded cash prizes as follows:
